- (2) assist the organizations that serve these individuals by providing information about other domestic violence resources.



# Domestic Violence in the Monroe County Legal System

This chart provides an abbreviated description of how a report is processed through the Monroe County legal system. While it is frequently more complex than what is shown here, it represents what happens in the Monroe County community (and this can vary greatly in other Indiana counties). The following pages also provide definitions and parameters for terms used.



## Investigating Agencies

There are multiple investigating agencies in Monroe County that first respond to a report of domestic violence, including the Bloomington Police Department, Monroe County Sheriff's Department, Ellettsville Police Department, Indiana University Police Department, and the Indiana State Police. Officers from these agencies investigate and then decide if they can establish probable cause that a crime has been committed

# Monroe County Prosecutor's Office

The Monroe County Prosecutor's Office reviews reports submitted by investigating agencies to determine if there is sufficient, credible, and admissible evidence to prove the charge beyond a reasonable doubt.





After charges are filed, the defendant will have an initial hearing, at which the defendant enters a plea of guilty or not guilty, is advised of their rights, is informed of the range of penalties, and may request a public defender. If the defendant enters a plea of not guilty, the case will proceed to a pretrial conference - a meeting between the prosecutor, defendant, and defense attorney. Possible case resolutions are represented in the corresponding chart.

# Pretrial Release and Supervision

All persons booked into the Monroe County Jail for any criminal offense will receive a risk assessment by the Probation Department and, whether released on their own recognizance or by issuance of a monetary bond, may be subject to pretrial conditions to include, but not limited to, electronic monitoring, daily reporting requirements, drug and alcohol testing, and/or regular meetings with an authorized representative of the probation department. A person arrested for an offense resulting in bodily injury to a person shall not be released until 24 hours have elapsed, unless ordered by a judge.



# Community Supervision



Upon conviction, a person may also be sentenced to the Monroe County Jail, prison, probation, another form of community supervision, and then released from custody upon completion of their sentence. Persons sentenced to a term of community supervision report to a probation officer either after their release from incarceration or immediately after their sentencing hearing.

The convicted person will meet with an intake probation officer to collect general information and to participate in a risk assessment and substance abuse assessment.

After the initial assessment, the person will be assigned to a supervision probation officer who will oversee their case. The Probation Department has a specialized unit, the Enhanced Supervision Unit (ESU), which provides more intensive supervision to offenders convicted of sex and violent offenses. The ESU probation officer will develop a case plan that is designed to reduce the risk the person poses to the community. (Continued)

The case plan may include such things as counseling, cognitive behavioral interventions, anger management programs, batterer's treatment, substance abuse treatment, etc. The probationer must successfully complete all court-ordered terms of community supervision, including compliance with the requirements of the case plan, before being released from probation.

## Incarceration

The terms "prison" and "jail" are often used interchangeably, but actually are very different. In Indiana, jails are usually administered by local Sheriffs. A jail is designed to confine people for short periods of time while they are serving a short sentence or awaiting trial. On the other hand, prisons are operated by the state government or the Federal Bureau of Prisons and are designed to house convicted criminals for much longer durations, including for life.

In Indiana, persons convicted of a Misdemeanor offense and/or a Level 6 Felony offense are typically not eligible to serve any term of incarceration in prison (the Indiana Department of Correction). They may typically serve their executed term of incarceration in the Monroe County Jail.

## Violations of Community Supervision

If a probationer fails to comply with any terms of community supervision, the probation officer may impose court-approved progressive sanctions for minor violations. However, if the probationer commits a new crime, the probation officer will file a petition with the court advising of the commission of a new crime. If the court determines that the probationer violated the terms of community supervision, the court may impose sanctions which may include the probationer serving their entire suspended sentence through incarceration.

# Emergency Housing for Pets

Many families struggle with how they can choose to care for their pets when faced with homelessness, fire, violence, or temporary weather related conditions. If a family cannot find temporary housing, afford temporary boarding or quickly find relocation for their pet, families face the risk of unnecessarily surrendering their pet to a shelter. To meet this community need, Monroe County Humane Association (MCHA) facilitates short-term, temporary housing of dogs and cats of families facing emergency situations (when typical or standard boarding options aren't available).

Because of the stress on both the animal and the foster family committed to helping pets in these situations, MCHA has elected a ten-day limit on Emergency Housing. When pets are surrendered for emergency housing, families also agree to their scheduled pick-up/return date appointment, and agree that if they miss that scheduled appointment, there are no extensions\*, and that the animal will immediately become property of MCHA. Upon surrender for emergency housing, families agree that the pets will be vaccinated against Rabies and any other required/necessary vaccines. Pets will be treated for fleas, and scheduled for spay/neuter during their ten day stay with MCHA. The average cost of care for an animal going into foster care is \$50. Fees can be sponsored (and MCHA has applied for grant funding to help offset these costs). Because pets are often kept off-site and in a foster home, there are no visits allowed between the family and the pet. Owners are welcome to call to check on their pet. MCHA extends a maximum of ten days of emergency housing.

\*In extreme situations, an additional 10-day stay can be extended. But it must be handled on-site, and in person with a new contract.

## About the Statistics

- An **Active Case** is still being investigated.
- Cases have been **Cleared by Arrest** when the perpetrator has been arrested for domestic battery.
- **Exceptional Clearance** means all leads have been exhausted.
- **Inactive cases** have not been resolved but are not expected to continue.
- A case is **Unfounded** when police are unable to arrest due to a lack of evidence.

The cases above do not represent all calls for service - only cases in which a crime was committed. All numbers provided are subject to change as further information is gathered regarding each incident. All cases are marked following the FBI's Uniformed Crime Reporting Guidelines.

DCS in Monroe County partners with numerous community agencies to provide services to families who have experienced abuse and neglect in their home of origin. Services include; assessments, psychological evaluations, drug treatment services, visitation, therapy, batterer's treatment, case management, and parenting skills. DCS hopes to provide safety, stability, wellbeing, and permanency to children through the course of these interventions.

DCS has specific protocol and policy which supports survivors of domestic violence in protecting their children from further abuse and neglect. DCS works with community partners, such as Middle Way House and POPS, to assure that families have support and resources available to them.

# Indianapolis Counseling Center Batterers Intervention Program

---

The primary purpose of the Indianapolis Counseling Center Batterers Intervention Program is to prevent violence to victims/survivors, families, and the community. Their objective is to challenge batterers on their justifications and excuses for their abusive behaviors and educate batterers on ways to effectively stop their domestic violence.

From January 1, 2018 through June 30, 2018, eight clients from Monroe County enrolled in domestic violence intimate partner abuse at the Indianapolis Counseling Center Batterers Intervention Program.

The Batterers Intervention Program is designed to prevent batterers from committing further abusive behaviors. Although the safety of the victim, family, and the community are the priority of this program, intervention focuses directly on the batterer through a cognitive and behavioral approach. Clients are counseled in group sessions lasting up to a year.

Legal advocacy resources include accompaniment and support during court hearings, providing referrals, and obtaining legal protections from abusers. Middle Way House Legal Advocates do not provide legal advice or representation, but they do support clients through legal processes.

Middle Way House shelter allows clients to live safely and affordably now, and to make decisions that support their long-term safety as well.

On-Scene Advocates discuss, process, and provide support to individuals who have experienced abuse. Advocates can help survivors as they navigate the various agencies they may work with post-assault, provide emotional support, and help connect survivors with other community resources to help meet immediate and long-term needs.

The Monroe Circuit Court Probation Department's mission is to promote a safer community by intervening in the lives of offenders, holding them accountable, and serving as a catalyst for positive change.



The Monroe County Prosecutor's Office represents the people of the State of Indiana to seek justice, promote greater public safety, and assist victims of crimes. The Prosecutor's Office receives reports from law enforcement agencies and files criminal charges in appropriate cases. They prosecute those who are guilty, while ensuring that the innocent are not wrongly convicted or oppressed. The office works proactively with law enforcement and other organizations to encourage crime prevention and education efforts that enhance public safety and improve the quality of life in the community.

## Understanding these Statistics

A Domestic Violence case is determined based upon a current or former intimate partner relationship between the victim and the defendant, and includes, but is not limited to, offenses like domestic battery, fraud, theft, cruelty to animals, and invasion of privacy.

The previous graph displays dispositions (resolutions) of Domestic Violence cases resolved from January 1, 2018 to June 30, 2018. Please continue for an explanation of the technical language in the graph:

***Guilty Plea to DV Case:*** Defendant was convicted of a domestic violence charge pursuant to a negotiated plea agreement.

***Guilty Plea to Companion Case:*** Defendant was convicted of an offense in a related case pursuant to a negotiated plea agreement.

***Dismissed:*** The charge against the defendant is dismissed. In situations where the evidence likely does not support an outright conviction the state may still seek to achieve a favorable outcome that provides a meaningful response to protect victim safety along with accountability for the defendant through supervision and rehabilitation services; including the following:

***Deferred Prosecution:*** Case remains pending for a period of time while defendant completes certain conditions with the charge dismissed upon successful completion.

***Deferred Sentencing Agreement (DSA):*** A program whereby the defendant pleads guilty to an offense and must successfully complete a Batterer's Treatment Program, consume no alcohol or illicit drugs, and commit no new criminal offense for one year to earn a dismissal of the charge.

The Protective Order Assistance Partnership (POAP) is a collaborative, co-located community partnership consisting of the Monroe County Clerk's Office, Middle Way House Inc., Monroe County Prosecutor's Office, the Indiana University School of Social Work, and the Indiana University Maurer Law School's Protective Order Project. Since 2011, POAP has provided free assistance to individuals within Monroe County who are seeking safety from threats or acts of domestic violence, family violence, intimate partner violence, sexual violence, and stalking. Using a co-located, multi-disciplinary service model housed within the Office of the Monroe County Clerk, Protective Order Assistants (POAs) explain eligibility for Protective Orders (POs) based upon Indiana's Civil Protection Order Act and provide assistance in completing the application for a PO in a safe, supportive, and confidential setting. In addition to assistance with paperwork, POAs provide crisis intervention services such as working with survivors to develop safety plans and providing referrals to appropriate community resources.

The Protective Order Project (POP) assists survivors of domestic violence, sexual assault, and stalking to obtain civil protective orders from the court. Law students, private volunteer attorneys, and Middle Way House partner to serve those seeking protective orders in Monroe and surrounding counties. POP's goal is to prevent further abuse, both by restraining the abuser and empowering the victim.

A **Protective Order** is a Civil Order from a judge that tells the abuser not to: abuse, harass, or contact the victim or any included member of the victim's household, directly or indirectly, in public or private; enter the home of the victim; and destroy any of the victim's property. If the abuser violates this order, then he or she may be subject to arrest and prosecution.
