

Total State & Local Tax Revenue


Indiana ranks 35th out of 50 states for total tax revenue — property taxes, individual income taxes and sales and excise taxes — as a share of total personal income in the state.


Combined Property & Local Income Tax Rates, 20 Indiana Cities Ranked
