

Q2 Have you visited Lower Cascades Park more, less, or the same amount since the road conversion pilot began on 3/13/20?





Q3 What activities have you done more of at Lower Cascades since the road conversion pilot began on 3/13/20? (Select all that apply.)







Q6 How would you categorize the impact to you of the road conversion pilot?






