Looking to buy your first home? Register now for HAND Home Buyers Club

The City of Bloomington's department of Housing and Neighborhood Development (HAND) offers a home buyers program in which participants can explore the possibility of affordable home ownership. The [Home Buyers Club](#) is comprised of two sessions which are held on two consecutive Saturdays. The first Saturday session is from 9:00 a.m. to 4:00 p.m. and the second Saturday session is from 9:00 a.m. to 1:00 p.m.



The goal of the class is to help first-time home buyers understand and overcome the obstacles involved in purchasing their first home and what to expect after buying a home.

Participants will have the opportunity to meet one-on-one with a housing counselor to discuss any potential obstacles to achieving their goal. Income eligible graduates may qualify for up to \$10,000 in Down Payment Closing Cost Assistance from HAND.

Registration is now open for the next Home Buyers Club session, to be held on Saturdays, September 18th and 25th. Meetings will be virtual. Additional assistance in the form of grants, not loans, is available from the Indiana Department of Homeland Security (IDHS). ***In order to be considered for an IDHS grant, you must apply for AND be deemed ineligible for an SBA loan.*** At that point, your case will be automatically referred to IDHS, and a representative from that department will contact you.
