## Planning a neighborhood event or small project? A Small & Simple Grant can help.

The Small & Simple Grant program offered by HAND provides neighborhood groups community building opportunities that might not otherwise be available. With a \$500 limit and no match component, Small & Simple Grant applications will be accepted from January 3 to September 1, 2022.

Grant funds may be used for many neighborhood projects, including:

- training sessions and educational workshops
- neighborhood newsletter mailings
- sustainability projects
- physical improvements
- special celebrations

Neighborhood groups of all kinds are eligible to apply for HAND grants. Groups need not be registered neighborhood associations. ## 2022 Community Development Block Grant deadlines approaching

The City of Bloomington is making preparations to start the 2022 Program Year for Community Development Block Grant (CDBG) dollars. These federal funds provide resources for social service and physical improvement community development projects in Bloomington.



#### MC-IRIS announces Reduce One Invasive Species Challenge for 2022!

The Reduce One Invasive Species Challenge (ROIS Challenge) hosted each year by Monroe County - Identify & Reduce Invasive Species (MC-IRIS) is an opportunity for people in Monroe County to learn how to identify one invasive species and prioritize its removal. In 2020, the focus was Asian Bush Honeysuckle and in 2021, Purple Wintercreeper vine. Callery Pear (aka Bradford Pear), a highly invasive tree that is a major concern in Monroe County, will be the MC-IRIS ROIS Challenge species in 2022.

Callery Pear has escaped from city green spaces, residential yards, and church and business landscaping. It spreads easily to neighboring properties, along right-of-way corridors, and into our surrounding forests, wetlands, and other sensitive natural areas; negatively impacting our watershed.

By focusing on one invasive plant species at a time, we learn how to identify it with confidence, discover how to control and dispose of it with greater efficiency, and by working together we can limit further spread. ## Bloomington Creative Glass Center Presents 12th Annual Great Glass Pumpkin Patch



The Bloomington Creative Glass Center (BCGC) is hosting its annual Great Glass Pumpkin Patch October 16th from 10:00 a.m. to 3:00 p.m. It will feature roughly 700 blown glass pumpkins spread out on the Courthouse lawn like a real pumpkin patch. You'll find traditional orange and green pumpkins, as well as purple, blue, black, polka-dot, swirl and more. Pumpkins range in price from \$20-\$200.

The event is free to enter and is open to the public. Tickets are not needed, though they do ask that folks maintain social distance. Inside the pumpkin patch, masks are required for everyone over 4 years of age. All the proceeds from this event will go towards the organization's arts education programs.
