Do some serious spring cleaning with a HAND Neighborhood Cleanup Grant

A cleanup is one of the most satisfying ways to build community in your neighborhood. Neighbors come together on a Saturday morning to rid their homes and properties of trash, scrap metal, hazardous materials, tires, and brush/limbs. There is also a "picker pile" for gently used items, because one person's trash just might be another's treasure. HAND provides the means of disposal, and the neighborhood provides the volunteers.

A successful neighborhood cleanup requires advanced planning and coordination among neighbors. It offers an opportunity to come together for the mutual benefit of the neighborhood. But most importantly, it's FUN!

HAND awards two Cleanup Grants per year on a competitive basis. These take place in the spring on a Saturday in April, May or June. 2022 application forms will be available January 3, 2022. The application deadline is March 7, 2022.

Neighborhood groups of all kinds are eligible to apply for HAND grants. Groups need not be City-registered neighborhood associations to apply. The Maple Heights Conservation District will automatically elevate in status to an historic district unless a majority of property owners object to the Bloomington Historic Preservation Commission in writing.



CBU again offering Residential Stormwater Grants in 2022

The City of Bloomington Utilities Department (CBU) invites homeowners to apply for funding through the fourth annual Residential Stormwater Grants Program. A total of \$100,000 has been dedicated in CBU's 2022 budget to this program assisting owners of single-family residential property with environmentally-friendly drainage projects such as rain gardens, bioswales, and detention pond maintenance.

CBU will host two public information meetings about the grant application process and project requirements:

- Thursday, December 2, 6:00 7:00 p.m. at Switchyard Park Pavilion, 1601 S. Rogers Street; and
- Tuesday, December 14, 6:00 7:00 p.m. at Banneker Community Center, 930 W. 7th Street.

If you are unable to attend, meetings will be recorded and available for viewing on the CBU grants webpage at www.bloomington.in.gov/utilities/stormwater/grants.

The application deadline is Tuesday, February 1, 2022 at 5:00 p.m. The application may be submitted online at <u>bloomington.in.gov/utilities/stormwater/grants</u>.




Projects will be reviewed by an internal review committee, an external committee including members of the public, and the City's Utilities Service Board. Projects will be ranked according to their potential to improve drainage and reduce the amount of pollutants discharged into our waterways. Projects containing "greener" stormwater solutions and impacting lower income census tracts will rank more favorably. Contiguous neighbors may apply together for one grant.



Tree updates from our Urban Forester

Erin Hatch, City of Bloomington Urban Forester, cares for and manages City-owned trees. With nearly 20,000 trees to care for, that's a BIG job! City-owned trees are those that grow on public land, including parks and public right-of-ways (ROWs).

The ROW typically extends beyond the edge of the roadway by about 10 feet. This area (referred to as an easement, and labeled "public right-of-way" in the graphic below) is reserved for public utilities, infrastructure, amenities, or other features such as drainage, tree preservation, environmental conservation, or pedestrian access (you can learn more in the <u>Bloomington municipal code 20.05.040 - Easements</u>).



Trees that grow in this 10-foot strip-regardless of whether a sidewalk is present--are considered City trees, and are thus the responsibility of the urban forester. You can search for Cityowned trees in your neighborhood by visiting the <u>TreeKeeper</u> website.

There is always work to do to maintain the urban canopy. Below are some of the tree-related activities the city has recently undertaken.

- The City contracted Bluestone Tree to conduct mature tree pruning on various Pin Oaks along East Wexley Rd, Kensington Pl, and South Stratford Dr, which were completed recently. This is part of an ongoing effort to address various mature pin oak pruning across the City. Previously other work was done on South Olcott Blvd.
- The City had contracted Davey Resource Group/Davey Tree Expert Company to conduct small tree pruning in the Old Northeast Downtown and Garden Hill neighborhoods. This work will continue in November and December. So far over 100 trees have been pruned.
- You can explore memorial/honorary trees and downtown plaque trees on the <u>TreeKeeper website</u>, including viewing pictures of associated plaques. This can be done by clicking on the magnifying glass to the left of the map, clicking the dropdown arrow next to "Select Quick Filters", and choosing "Memorial trees".

HAND neighborhood support


Mental Health presentation and Q&A at the library

Invasive Spotlight: Chinese yam

Are you interested in reducing the invasive plants on your property, but just don't know where to start? Try identifying just one species and focus on reducing its numbers.

Recently Gillian Field, of MC-IRIS, came across an infestation of <u>Chinese Yam</u>, and sent along some helpful information to assist property owners in identifying it. Like many invasive plants, it was first introduced to North America in the 1800s as an ornamental plant. Now it is regulated under the <u>Indiana Terrestrial Plant Rule</u>, a list of 44 plants that are illegal to sell, gift, barter, exchange, distribute, transport, or introduce in the state of Indiana.
