# WHAT TO DO WHEN YOUR RENT IS LATE

Life doesn't always go as planned. If you're struggling to afford immediate housing expenses, follow these tips to avoid eviction and get back on track.

## Communicate

If you're having trouble making payments on time, let your landlord know as soon as possible. You might be able to work out a solution together. If you need free help talking to your landlord about a payment plan, you can contact the Community Justice & Mediation Center (CJAM) at 812-336-8677 or email them at: admin@cjamcenter.org.

## Find Help

Reach out to your local social service agencies for help with financial assistance. Many agencies help people on a first-come, first-served basis, so it's a good idea to reach out to them before your rent is due.

# Plan Ahead

Whether it's a one-time thing or happens often, being late on rent might mean you need to look at your expenses and make some changes. Utilizing local resources like food banks, utility assistance, and housing vouchers can provide relief during tough times.
